Course Title: Beginning Racquetball

Course Description: PHED 1120 Beginning Racquetball

Instruction in rules and basic skills; develops the fundamental techniques of court play for beginners. Participation by skill level assures vigorous activity for cardiovascular fitness.

Credit Hours: 1 **Lab Hours:** 3

College Repeat Policy: A student may repeat this course only once after receiving a grade, including “W”.

Student Learning Outcomes:

1. To demonstrate proper knowledge of court terms and playing terms.
2. To recognize the basic game strategies and rules of racquetball.
3. To demonstrate fundamental skills, shots and serves necessary to play at a beginning level.
4. To understand that racquetball is a lifetime fitness activity.
5. To demonstrate sport and fitness-related skills and apply the use of the skills in lifetime activity in the promotion of health and wellness.
6. To demonstrate knowledge of nutrition and its implications for sport performance, physical fitness, and wellness.
7. To recognize the importance of the relationship between lifetime activity and the quality of life.
8. To demonstrate the biomechanics of fundamental movements and skills.
9. To develop the kinesthetic sense in the process of acquiring movement skills.

Attendance Policy:
