COURSE TITLE: General Physics I

CREDIT HRS: 4 **LECTURE HRS:**3 **LAB HRS:** 3

PREREQUISITE: Pass reading requirement of TSI; high school pre-calculus or equivalent within the last five years with a “C” or better

COREQUISITE: Lab

COURSE DESCRIPTION:

Algebra-based physics course for the science major in areas of biology, medicine, and pharmacy. Includes laws of motion of objects, heat, work, energy, and sound. Lab required.

MEASURABLE STUDENT LEARNING OUTCOMES:

Expected Student Learning Outcomes – Upon successful completion of this course, students should be able to do the following:

1. Demonstrate knowledge of basic units of measurement and their relationships
2. Solve problems through equations involving the motion of bodies
3. Solve problems involving forces including frictional forces
4. Solve problems involving work and energy
5. Solve problems involving momentum and collisions
6. Explain the basic principles of fluid dynamics
7. Apply the principles of heat and thermodynamics
8. Explain and apply the principles of wave motion and sound
9. Demonstrate the collections, analysis, and reporting of data using the scientific method
